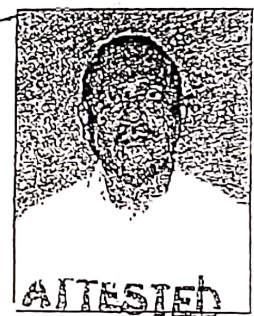

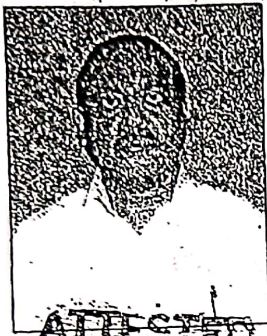

- IV) To make rules and regulations from time to time for the management and conduct of the affairs of the Trust and its properties and assets.

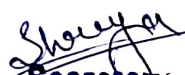
POWER OF TRUSTEES

The Trustees will also have following powers:-

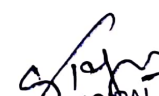

RIGHTS OF THE TRUSTEES

- i) The Trustees will not be entitled to receive any remuneration as Trustees by any reimburse themselves of all expenses actually incurred by them in connection with Trust or their duties relating thereto. If any Trustees empowered by the Board of Trustees to act as full time trustee to achieve the object of the Trust may entitled to get a suitable maintenance remuneration with the consent of other Co- Trustees after passing a resolution of such effect in the meeting of Board of Trustees.
- ii) The Trustees may from time to time associate with the activities of Trust any person or persons of public eminence as patron or patron in chief and may appoint or make provision for appointment of committee or sub-committees for conduct of the affairs of the Trust for the purpose of administration of any Project undertaken by the Trust in consonance with the object of the Trust. Appointment of the committee members shall be done by the Board of Trustees. However the Managing Trustees of the committee so appointed by the members of the direct control and supervision of Board of Trustees.
- iii) The Trustees may from time to time, frame scheme, rules & regulations, laws and bye laws for regulating the affairs of the projects undertaken by the Trust in pursuance to the various objects. Such rules as framed by the Board of Trustees for the contract of affairs of the project shall be binding and no deviation shall be permissible in any of the rules so framed by any authority whatsoever connected with the said project without the prior approval of the Board of Trustees.
- iv) The Trustees shall have an advisory committee of national level to advise the Trustees on the activities of the Trust and to suggest how to make them better serve its aims and objects. The strength of the Advisory Committee shall not exceed 50 (fifty) at a given time. The members of the advisory committee shall share the Trust in honorary capacity but they may be
